# **Code of Ethics Reminder**

REALTORS® are required to complete ethics training of not less than 2 hours, 30 min. of instructional time within a <u>three-year cycle</u>. The training must meet specific learning objectives and criteria established by the National Association of REALTORS®.

Any course taken through our association, through another REALTOR association (local or State) or through NAR are automatically approved. However, if you choose to take the course from a third-party provider, please make sure this course will be approved by contacting our office.

Current cycle runs from 1/1/2022 to 12/31/2024. Please send a copy of your certificate of completion to the office so we may update your record with NAR.

# **2025** Association Dues and payments

Please note: Individual Invoices were sent to your managing broker at the end of October. If you have not received a copy of that invoice, please contact them for a copy.

The deadline for the 2025 Association Dues is November 30, 2024 with a grace period that runs through December 15, 2024. All REALTOR members can access their invoice and pay their dues online at www.nar.realtor. Log in is required so please make sure you are able to access your account.

Online payment allows members to pay invoices directly online with a credit card or electronic

check. The system automatically adds late fees and other charges to the online invoice, and does not allow members to make a mistake or pay the wrong amount. Reducing the chance of member error saves time and resources on dues collection each year. When members log in and pull up their invoices, they will see an option to "pay invoice". Members may then pay their dues, print a copy of the invoice and also download the invoice. The system validates payments in real time and sends the association a report confirming the payment.


This feature saves associations the hassle of tracking down members because of an incorrect credit card number or expired card, along with saving them from entering the credit card information in

the first place.

Accepted cards include MasterCard,

Visa and Amex,, or you have the option to pay with an electronic check. Should you chose this option you will be prompted to enter your information from your drivers license as seen in this photo. On the next screen you will enter your check number and ALL numbers located at the bottom of your check, as shown in the photo. You must enter all numbers including the check number!

We would like to thank everyone for paying their dues in a timely manner. Once you have paid you have an option to print out a receipt for your records. Payments are fast and easy using this system and there are no checks lost in the



mail. Remember that the deadline to submit your dues was **November 30, 2024** with a grace period through <u>December 15, 2024! After this date a \$100 late fee will be automatically ap-</u> <u>plied to your invoice. To date less than half of our membership have submitted their</u> <u>2025 dues!</u>

If you are experiencing issues access your account please contact the board office for assistance. Please print a copy of your invoice and receipt for your records. You may view all disclaimers once you have accessed your invoice.

## NAR 2025 Membership Requirements

**REALTORS®** are required to complete Fair Housing / Anti-Bias Training upon becoming a member, and **every** 3 years thereafter, coinciding with the Code of Ethics training timeline. This requirement is in addition to the Code of Ethics training. Qualified training must be of not less than 2 hours of instructional time. The training must meet specific learning objectives and criteria established by the National Association of REALTORS<sup>®</sup>. This requirement will begin January 1, 2025 with a deadline of December 31, **2027** for Cycle 8.

Training may be completed through NAR's online courses or through another method, such as online or classroom courses via local/state associations.

For those of you who have completed a **Fairhaven Simulation** in the past, NAR has created a new Fairhaven Simulation which will launch in 2025. This new platform will satisfy the Fair Housing Training Requirement.

LPCAR will be including a Fair Housing CE during the cycle that will also satisfy this new requirement.

Any Code of Ethics Course taken through the National Association of REALTORS updates your NAR record automatically.

#### **Stay Safe This Winter!**

Make sure your vehicle has a good quality set of snow tires with studs to keep from going off the road and getting stuck where AAA will not go. Also, make sure you have a full tank of gas.

Daylight is short during the winter months so plan accordingly.

When out on showings make sure to carry emergency essentials such as boots, blankets, Consider having a good quality snow shovel, tow rope, LED flash light and battery jump starter as part of your arsenal as well.



#### La Porte County Health Department Ordinance 2024-3 Section 4: Potable Water Well

A. Each potable well on the property shall be analyzed by a certified laboratory for the following contaminants:

- 1) Total coliform
- 2) E. coli
- 3) Nitrate (N03)
- 4) Arsenic
- 5) Lead for homes built prior to 1973

B. Any additional tests as deemed reasonable and ordered by the Health Officer to the extent that the tests protect against a health threat.

C. The laboratory shall report the results of the water analysis along with the U.S. Environmental Protection Agency Drinking Water Standard so that it is clear to the lay person whether the water meets standards.

The Health Department has confirmed that tests conducted after November 1, 2024 will require testing for the contaminants listed above. A new addendum will be available by the end of the month. It is currently under review with our board attorney. Once final approval is received we will send the form to Ziplogic to be included in the LPCAR local library.



2025 IAR Legal Forms Changes: Broker-to-Broker Compensation

Effective January 2, 2025

- The **Broker Compensation Agreement** will be eliminated from IAR's forms library.
- The paragraph dealing with Buyer Broker Compensation options in the Listing Contract will also be deleted (page 2, Section 1B).
- These changes mean that IAR forms will no longer explicitly provide the option of listing broker-to-buyer broker compensation payments.
