NAR Code of Ethics—Cycle 7: Jan. 2022-Dec. 2024

REALTOR® Members - just a reminder that we are currently in cycle 7 for the NAR Code of Ethics requirement. REALTORS® are required to complete ethics training of not less than 2 hours, 30 minutes of instructional time. The training must meet specific learning objectives and criteria established by the National Association of REALTORS®.

There are many Code of Ethics training providers and many of you have taken a course through a school or CE sponsor. However, we must receive a copy of your Certificate of completion in order to update your NAR record. If a copy is not sent, we have no way of knowing that you have completed a course.

If you have checked on the NAR website to view your Code of Ethics status and it shows that it is not completed, please send a copy of your COE certificate as soon as possible. If you have taken a course through LPCAR or NAR, your record will be updated automatically. New members who have taken our orientation class have also fulfilled the requirement. Please contact board office if you have questions.


Whitney VanAsdall/Blackrock Real Estate

The Election will take place during our October General Membership Meeting. Please note that ballots will not be distributed until after all of our candidates have had an opportunity to address those in attendance and the vote is called.

2025 Association Dues and payments

The 2025 billing cycle is right around the corner. All REALTOR members can access their invoice and pay their dues online at **www.nar.realtor** once the invoices have been released. Log in is required so please make sure you are able to access your account. The 2025 dues are \$716 per REALTOR Member *upon approval at our October General Membership Meeting*. (secondary and local only will pay only those amounts required).



Online payment allows members to pay invoices directly online with a credit card or electronic check. The system automatically adds late fees and other charges to the online invoice, and does not allow members to make a mistake or pay the wrong amount. Reducing the chance of member error saves time and resources on dues collection each year. When members log in and pull up their invoices, they will see an option to "pay invoice". Members may then pay their dues, print a copy of the invoice and also download the invoice. The system validates payments in real time and sends the association a report confirming the payment.

This feature saves associations the hassle of tracking down members because of an incorrect credit card number or expired card, along with saving them from entering

the credit card information in the first place.

Accepted cards include MasterCard, Visa and Amex, or you have the option to pay with an electronic check. Should you chose this option you will be prompted to enter your information from your drivers license as seen in this photo. On the next screen you will enter your check number and ALL numbers located at the bottom of your check, as shown in the photo. You must enter all numbers including the check number! We would like to thank everyone for paying their dues in a timely manner. Once you have paid you have an option to print out a receipt for your records. Payments are fast and easy using this system and there are no checks lost in the mail.



Remember that the deadline to submit your dues in **November 30, 2024** with a grace period through **December 15, 2024!** After this date a \$100 late fee will be automatically applied to your invoice.

If you are experiencing issues access your account please contact the board office for assistance.

Deserving Children Shopping Event Information

Our charity auction event is a year long endeavor with the objective of funding the annual Deserving Children Charity Shopping Tour each Decem-

ber. Funds raised by the auction and the LP Roof Sit committee are used to take local area children shopping for necessities such as coats, boots, clothes and even a toy.

This year the dates for this events will be **December 3, 2024 for La Porte** and **December 4, 2024 for Michigan City.** Children participating in the shopping are picked up from their homes by volunteer chaperones, taken to either the La Porte Civic Auditorium or the Orak Shrine in Michigan City for a visit with Santa, dinner, and receive a stocking full of goodies before heading out to shop. Once the shopping is completed they are taken back to their home.

Each chaperone is provided with a \$150 voucher (spending limit) to be used at the designated shopping location. Participating locations are Walmart in La Porte, and Walmart and Meijer in Michigan City.

Doors open at 4:00 p.m. CST at both the Civic Auditorium and the Orak Shrine on the designated days and the shopping committee asks that all children begin their shopping no later than 6:30 p.m.



The shopping committee is seeking volunteer chaperones for the event. Chaperones will undergo a background check and all chaperones must be at least 18 years old. All Chaperones must have a partner with them and they must also be at least 18 years old.




