(state laws vary) all in one place, leading to safer and more productive interactions.





## **NAR Code of Ethics Requirement**

NAR's Board of Directors approved a change to the Code of Ethics training requirement, extending it from every two years to every three years. This extends the current cycle deadline from March 1, 2022, to <u>Dec. 31, 2024. (this is not a PLA requirement!)</u>

REALTORS® are required to complete ethics training of not less than 2 hours, 30 minutes of instructional time. The training must meet specific learning objectives and criteria established by the National Association of REALTORS®. Training may be completed through NAR's online courses or through another method, such as online or classroom courses via local/state associations. We ask that all members send in a copy of their completed COE Certificate so we may update your record. (if you have taken it through LPCAR or NAR your record will be updated—no need to send in a certificate!) **Please verify that your course will be accepted by the association prior to taking the course!** 

## **2024 LPCAR Scholarships**



LPCAR is pleased to offer Scholarships in the amount of <u>\$1000</u> each, to area students who plan on pursuing further education after graduation or are currently attending a college or trade school and who are related to a **REALTOR or Affiliate** member of LPCAR.

This award will be given to a person demonstrating <u>outstanding community involvement</u> who is planning to pursue further education through an accredited college, university, or trade school or are currently attending college or a trade school.

Applications will be available on our website in February. The application also requires an essay of 200 words or less explaining why the scholarship should be awarded. Any application received without the essay will not be considered during the selection process. It is important for the student to complete all parts of the application

There will be **4 (four) Scholarships available.** Three will be available to any student related to an LPCAR member—REALTOR or Affiliate member, and one scholarship is available with the same criteria but with one additional requirement—**the family member must have served on the board of directors**—either in the past or a current board member.

This is our Board of Director Service Scholarship! **Eligible applicants may apply to both scholarships but may only be selected for one.** 

The deadline for this year is <u>April 15, 2024.</u> Please download the application (when posted) and have your student complete and send the form back by the deadline. Students of family members of LPCAR are eligible for this scholarship so we encourage them to apply as soon as possible.
