# REALTOR Dues Reminder: Grace Period Ends 12/30/2018

We are now in December—Have you paid your 2019 dues yet? If not you have until December 30, 2018 midnight to submit your payment and avoid any late fees.

All REALTOR members should submit their 2019 dues in order to remain a member in good standing. Invoices were sent out to managing brokers at the end of October. The deadline for dues payment was November 30, 2018 with a grace period that runs through December 30, 2018 at midnight. A late fee will automatically be added to your invoice if paid after that date.

Members should make their payment online at www.nar.realtor. You will need to log into your account to make your payment. If you do not have an account, you can create one using your NRDS number located on your invoice. Please verify your current email address with the board office prior to creating your account or recovering a forgotten password/username. Some of you started with one email but no longer have access or have changed offices. Please contact the board office with any questions or assistance. Thank you.
